#### Visitors at Camelot

Mrs. Ralph C. Bunnell, Kenmore, NY, wrote to me seeking information about her husband's family. I was able to furnish his ancestry back to William Bunnell. On 6 October Mr. and Mrs. Bunnell visited us here. Ralph's roots are here in Laceyville. In fact, from my front porch I can see the houses where his grandfather and his great-grandfather lived. They brought my records up to date on current members of the family, and we shared information on other local families in which we both have an interest.

On 6 November Mr. and Mrs. Clement M. Bonnell III stopped in to see us. Clem brought his charts along and gave me a lot of additions and corrections to the descendants of Clement duMont Bonnell CB310016. He also left a copy of a fascinating memoir by Georgia Bonnell Walton recalling her early life in Vincennes, IN. She was the daughter of George William Bonnell CB330221, who raised, trained and raced horses. More recently Clem sent me a large packet of genealogical data regarding the descendants of Clement duMont Bonnell, including a copy of "Genealogy of the Bonnell Family," written by Arthur Franklin Bonnell many years ago. I had heard of this document back in 1963 when I corresponded with Arthur Bonnell's nephew Gilbert Bonnell, of White house Station, NJ. Gilbert told me at that time that the manuscript was lost, and I am delighted now that Clem has been able to locate it and obtain a copy for me.

Recently I received a letter from Ted Wallace, of Brantford, Ontario, requesting a copy of the Newsletter. He is a member of the Brantford Genealogical Society, which is affiliated with the Ontario Genealogical Society. Anyone interested in membership in those organizations can get information from Ted. He had children there, and Mr. Wallace's offer would be especially interesting to any of the descendants of Enos.

### Bible Record Correction

Judith Osborn, St. Petersburg, FL, writes:

"The Bible records you published in the last issue filled in a little data for us as Stephen and Freelove (Williams) Bunnell were brother & sister-in-law of my 4<sup>th</sup> great grandfather Nathaniel "Peg Leg" Bunnell. Our records, however, indicate a small discrepancy with the "Notes on Family" fastened into the Bible. "Peg Leg" and 1<sup>st</sup> wife Elizabeth Donovan had eight children. Brazilla seems to be missing...Brazilla: 02 Apr 1807 - 29 Dec 1891 marr. Sophia Bumgarner 28 Aug 1810 - 23 Jan 1883; they had issue - Telitha Ann, Rebecca, George W., Sarah J., Sophia L., Susan J., Margaret C., and John A. "Peg Leg" married (2) 11 Nov 1821 Elizabeth (Price) Bunnell, his widowed sister-in-law, who was dau of Veasey Price and Anne Barton. I would question the dau Nancy listed as "Peg Leg's." We have an Eliza b. 1816 who is not listed, but no Nancy. "Peg Leg's" brother David had a dau Nancy who is not listed in the notes attached to the Bible. I suspect that someone was a bit confused about whose dau she was. Nancy married "Peg Leg's" son Thomas in 1835. As it is, we then have a first cousin marriage here; if Nancy really were Nathaniel's daughter, we'd have an incestuous marriage! A brother and sister! And while we're on this line, do you happen to know who Mary Daniels was? We've come up empty-handed on every occasion that a search has been initiated."

Thanks, Judy, for clarifying this matter. Here is what little I have on Mary Daniels, and perhaps one of our readers can add to it:

Stephen Bunnell CB300135, son of James, was born at Scotch Plains, Essex (now Union) co, NJ, in 1731. In 1754 (or 1764) he married Mary (Daniels) Blackford, widow of Nathaniel Blackford. They had eight children: James, Jonas, Brazilla, David, Stephen, Rhoda, Mary and Nathaniel. Stephen was born 25 June 1767 and Nathaniel was born 3 July 1778. For the other children I have two sets of approximate dates, one set beginning in 1755 and the other in 1765, corresponding to the two marriage dates given above. We find that a Mary Daniels married Nathaniel Blackford on 20 August 1759 at the Scotch Plains Baptist Church. This is probably the same Mary Daniels, which would indicate that the second set of dates is the correct one. I have no further information on Mary Daniels.

### INTERNATIONAL GENEALOGICAL INDEX

For the last several issues I have been printing extracts from the IGI sent to me by Ruthelle Finnerty and Jerry Hatch. These extracts were from the 1984 update of the IGI. Now I am informed that the 1988 edition has been delivered to the family history centers across the country. World-wide, it now contains 118 million entries, 30 million more than the 1984 edition. Judy Wilkins, of Salt Lake City, UT, wrote as follows:

"The 1988 version of the IGI has been available to the public for several months now. I am enclosing a 1984/1988 comparison for the British Isles showing the number of names on the 1988 for each shire in England. The increase for England is a little over 9%." (36 million to 39 million.)

"It is true that microfilming is going on in England at the present time, as is the case in many places worldwide. It might be interesting to you to know that the LDS Church is adding microfilm to its collections at the rate of 4000 rolls per month. That figures out to 200 rolls per working day! Of course that figure is worldwide and not just British Isles.

IGI (Cont'd)

"There are some problems with the 1988 IGI, as anyone who has worked with it very much has already recognized. Due to a computer malfunction sometime last year, some entries were lost which had appeared in earlier editions of the IGI. The word is that it involves 'only a small percentage of entries', but I discovered a dozen missing in a matter of twenty or thirty minutes that I happened to have personal knowledge of. That makes me wonder that the actual number of lost entries is, of if anyone really knows.

"There is an excellent article in the September/October 1988 issue of the Genealogical Helper that gives detailed information about the 1988 IGI. Included in that piece is a request to inform the Family history Department, IGI Committee, of any missing records we are aware of.

"Still, the IGI is a great tool."

With the 1988 update now available, I believe it makes sense to delay printing any more of the Bunnell/Bonnell extracts until I can get copies of the new lists. Geneva Draper, of Pocatello, ID, has already offered to make copies of some states. If anyone else wants to volunteer, I will try to coordinate the effort to avoid duplication.



# Some Thoughts on Research

Whenever I receive an inquiry from someone new, it gives me a lot of pleasure if I can pull together and send him or her the full line of descent from the immigrant William Bunnell. That has happened a number of times since I started the Newsletter. Unfortunately, most of the time that is not the case. The number of unconnected branches that keep turning up continues to amaze me. I usually spend quite a bit of time on them trying to relate them to other information in my files, and I am always glad to share anything that might be useful in your research.

However, I don't often get the chance to get out to do original research myself, and I rely on your efforts to help me bring all this together. Here is just one example that has impressed me as a classic step-by-step approach to family tree climbing: When Gwen Quickel, of Lake Jackson, TX, first wrote to me, she said she had reached a dead end in hunting for her husband's Bonnell ancestors. All they knew was that his grandfather's surname was Bonnell. The grandparents were divorced early in this century, the grandmother remarried, and even the grandfather's given name was lost.

They began an intensive search of cemeteries, court houses and libraries in their area. Within a month they had their first success. They found a marriage record and a birth record which proved that the grandfather's name was Stephen E. Bonnell. Census records for 1880 and 1900 showed that he was son of William A. and Molly E. Bonnell, who were both born in Virginia. At this point I was unable to help, except to suggest that the Bonnell seemed to point to a New Jersey origin. Their research continued with great persistence and Gwen sent me a lot of data which filled in some of the descendants of William A., but didn't give a clue as to his parents.

Some months later, after a research trip to Oklahoma, where they studied city directories, newspaper archives and other sources, they learned that William A. was a Confederate soldier and had received a pension. They discovered his date and place of birth and his date of death and place of burial. Still nothing about his parents.

Then in October this year they obtained a copy of William A. Bonnell's death certificate, giving the name of his father as Ludwell Bonnell, b. in Ohio. At last I was able to help. Claude Bunnell's Database had a Ludwell Bonnell and everything fit into place. I was able to extract a great deal of information from the database to send to Gwen, including the name of Ludwell's father, William Bonnel, who was born about 1790 in New Jersey. Since then the Quickels have searched Virginia records extensively and have added many facts to the story. Now the question is, who was William Bonnel of New Jersey? Gwen's query is on the last page of this Newsletter.

A number of you are trying to discover how, or even if, your Bunnell or Bonnell ancestors fit into the William Bunnell line. As you pursue your studies of your end back in time, I thought it might be useful to highlight the "empty branches" of the family tree, where additional descendants might be found.

FIRST GENERATION: This, of course, was William himself. He and Ann had three sons, two of whom grew to adulthood. This seems to be complete.

SECOND GENERATION: Benjamin Bunnell and his brother Nathaniel Bonnell each had large families. The births of Benjamin's children were all recorded in the New Haven Vital Statistics. I'm sure they are complete. Nathaniel's children, born in Elizabethtown, NJ, were not officially recorded. He could possibly have had other children we haven't yet discovered, but there is no reason to think so at this time.

THIRD GENERATION: Benjamin Bunnell's grandchildren in Connecticut seem to be complete and well-recorded. In New Jersey, however, two of Nathaniel's sons, SAMUEL and BENJAMIN, are not known to have had any children. Now, a couple of items uncovered and sent to me by Ellen Dorn, Alhambra, CA, make me wonder. Samuel married Abigail, step-daughter of Samuel Rose or Roos. Samuel Bonnell died 11 January 1711/12. A record in the New Jersey Archives, not dated, but apparently about that time, states that Benjamin Bunhill with the consent of his mother Abigel, binds himself to Anthony Aliffe and wife. At this period I find no other Abigail who could have been this Benjamin's mother, and I suspect Benjamin was the son of Samuel. If that could be proved, and if we could prove identity with the Benjamin who married Eleanor and was the father of Aaron Bonnell, a lot of Bonnell researchers would be happy. The reference in the New Jersey Archives is to Volume 23, page 348. If any of you have the opportunity to pursue this line of inquiry, it could be very fruitful.

BENJAMIN BONNELL married Sarah Potter, a woman who was 14 years younger than he. Her will makes it clear that she, at least, did not have any children. Until recently I had no reason to think that he might have. But again Ellen Dorn found a notice in the New Jersey Gardiner papers of a Quit Claim signed by Benjamin and Margaret Bonnell on 13 March 1734/5. Since Benjamin, son of Nathaniel, was the only one of this name I know of, this seems to indicate that Benjamin had a first wife, Margaret \_\_\_\_\_, and that Sarah Potter was a later marriage. If so, some of the unattached Bonnells might be descendants of Benjamin and Margaret. I suspect that only intensive search of New Jersey deeds and legal documents will answer the question.

FOURTH GENERATION: In the Connecticut branch I find only two members of this generation whose children are not accounted for:

ISAAC BUNNELL (Benjamin, Benjamin, William) was born 30 August 1713 at New Haven, CT (ref: NHVR and Jacobus). The only other reference I have ever found regarding this Isaac comes from one of the box charts prepared and sent to me by Claude B. Mitchell. On the copy of the chart, written in ink after the chart was photocopied, was the notation in Isaac's box, "D 14 June 1734 NHVR." I assume that NHVR in this case stands for New Haven Vital Records. However, when I went through the published Vital Records of New Haven to 1850 and copied out every reference to Bunnells I did not find this reference to Isaac's death. It is possible that I missed it. Even so, he would have had time to have married and fathered one or more children. Isaac's parents moved to New Milford, CT, a year or so after his birth and lived there the rest of their lives, and Isaac must have been brought up there. Did he move away as a young man, only to die in New Haven at age 21, or to marry and father a family elsewhere?

JOHN BUNNELL (Israel, Benjamin, William) was born 4 September 1717 at New Haven, CT (ref: NHVR and Jacobus). He died in 1773 (ref: Jacobus). Ruth Duncan on page 16 of her book "William Bunnell and His

Descendants," gives the following: "JOHN b. 4 Sept. 1717; d 7 July 1773 (Haddam Neck Congregational Church records.) The NEW HAVEN TOWN RECORDS, Vol. III states: 'April 7, 1760 took oath of freeman.' John studied theology at Yale College and was licensed to preach in 1738. He was employed as a preacher and was a teacher in Haddam when he died." There is no mention of whether or not he was married or had a family.

Turning to Generation Four of the New Jersey branch, we find:

ISAAC BONNELL (Isaac, Nathaniel, William) was bornn in 1697 at Elizabethtown, NJ. He died 15 February 1736 "in ye 38th year of his age." He was buried in the burying ground of the First Presbyterian Church, Elizabeth, NJ. No further information.

JACOB BONNELL (Isaac, Nathaniel, William) was born at Elizabethtown, NJ, about 1702. No further information.

JOHN BONNELL (Isaac, Nathaniel, William) was born at Elizabethtown, NJ, about 1704. No further information.

WILLIAM BONNELL (Isaac, Nathaniel, William) was born at Elizabethtown, NJ, about 1706. No further information. These last three might have died in infancy or they might have survived to raise families of their own.

Also, descendants, if any, of Samuel and Benjamin Bonnell mentioned above in the Third Generation.

Each succeeding generation will show more "empty branches", and in later issues I will highlight as many as I can. In the meantime, I hope this approach helps to focus research opportunities for some of you.

#### AN UNATTACHED BRANCH

A-1. CB005836. DAVID BUNNELL was born in Kentucky in 1792. He was a blacksmith. He married \_\_\_ McCALL?. They had at least three children born in Indiana. His wife died early, as he was a widower when he moved to Platte co, MO, with his three daughters. The first two, at least, were married in Platte co. It is said that the Bunnells left Indiana, came to Missouri, then over into Kansas Territory before it was a state. They were in Leavenworth co, KS, then on to Jackson co, KS, and into Shawnee co, KS. In 1860 David was living in Easton twp, Leavenworth co, KS, with his son-in-law and daughter, Lewis and Louisa Cox.

### WHO WAS MARY HOLDREN?

Joan el Murray, palatine, IL, writes: "How would you feel about writing a piece on Mary (Elizabeth?) Holdron (Holdern) in an upcoming newsletter?" I would be happy to, and there is no time like the present, especially since Joan sent along enough material to make it worth while.

Mary (or Mary Elizabeth) or Elizabeth Mary) Holdren (or Holdern or Haldron) was the wife of Solomon Bunnell CB290004 (Benjamin, Benjamin, William). Solomon was born 27 Octoer 1705 in New Haven, CT. About 1737 he married Mary and moved to Kingwood, Hunterdon co, NJ. In November 1755 they removed again, to what was called "The Hollow" in Middle Smithfield twp, then Northampton (now Monroe co), PA. He signed the Oath of Allegiance in Northampton co, purchased land, and remained there until he died in 1779. They had three sons and five daughters, and their descendants number in the thousands all over the United States.

That is all I had gleaned about Solomon and Mary until I received a copy of the John A. Biles manuscript. Quoting now from his manuscript:

"The following is a copy of the notes taken by the author in the spring of 1881 while on a visit to his great aunt Katharine Bunnell (Carney) Crawford's, at the home of Katherine and her husband, Benjamin Crawford, then residing about two miles north of Meshoppen, Pa. near the home of Rebecca Bunnell Davis.

"She was then 84 years of age, in good health and sound mind with a clean recollection of the events of her early childhood. She possessed numerous antique articles which she showed with apparent pride. A month them my notes show the following: An old fashioned stand which had been in the family 74 years; an old bedstead for 63 years; a very large heavy pewter plate that she could trace to 1797; her great-grandmother's flat irons with a date as early as 1775; a pair of shears that had belonged to her great-grandmother.

"Her husband, Benjamin Crawford, aged 87, was cutting his summer's wood when this visit was made in the month of March and preparing for garden work, while his wife performed all the necessary duties of the household.

"In speaking of her grandfather, Solomon Bunnell, she said he was a Yankee from Rhode Island, she thought, born in 1705, and died in 1779. When a young man he came from New Haven, Conn. with his brother Nathaniel stopping for a time at Elizabethtown, N.J. with relatives, an uncle, I think she mentioned. Nathaniel remained there and changed the spelling of his name to Bonnell instead of Bunnell as before. Solomon came on to Kingwood, Hunterdon Co., N.J. where he remained until the beginning of the French and Indian War, when he stated for the valley of the 'Sisquehannah', as she called it. Near the Wind Gap, near Stroudsburg, Pa., they met the refugees fleeing from the first Indian massacre in the valley after Braddock's defeat at Fort Pitt. They turned off into 'The Hollow' and settled. He brought with him young apple trees which they planted, mentioned elsewhere in this book. Her grandmother's maiden name, she said, was Mary Holdren, a low Dutch girl, born in 1707, and lived till 1804. Their children were:

Isaac who married Laner Barkaloe.

Lizzie married Drake

Solomon, Jr.

Rachel who married Brink

Benjamin, born in 1741 and died 1814, (her father).

Patty (or Martha) married Robert Hanners. They fought and

parted. She then married John Tock.

Polly (or Mary) married Elias Daily"

# Mary Holdren (Cont'd)

There are, of course, many many errors in the above account, either from Katharine Crawford's recollection or from Mr. Biles' transcription of it. However, apparently on the basis of that conversation, Mr. Biles states on a later page that in 1737 Solomon Bunnell married Mary Holdren, b. 1707, d. 1804, a native of Holland. I would certainly doubt that she was born in Holland rather than in the American colonies, but I have never found anything else that even hinted at her origin. Joan Murray's recent letter now suggests a possible line of descent. Perhaps one of our readers can provide further information. Joan says:

- "My own theory is that she is the daughter of John and Cornelia Van Tienhoven (Holst) Haldron. John was the son of William Waldron, the emigrant who lived in Harlem, New York and died there in 1687.
- "John and Cornelia had a daughter Elizabeth, baptized 5 October 1709. Since William Haldron had only two sons: Henry and John, and Henry died without issue, it appears only John remains as ancestor of the Haldrons. There seems to have been only one Haldron family in the colonies during that time period.
- "John's sister, Anna, married a John Allen and moved to Milford, CN by 1705.
- "John is known to have moved from Harlem to Tappan NY circa 1713 right on the New Jersey border, and not that far from Elizabethtown, where perhaps Mary Haldron married Solomon Bunnell.
- "John had a son, William, who moved from Tappan to Harrington Twp NJ in Bergen Co. (I am still searching for a book on border changes in northern NJ and southern NY. I believe I read somewhere way back that southern NY was once a part of NJ.
- "At any rate, this Haldron family certainly had an opportunity of meeting up with the Bunnells either in Milford or New Jersey.
- "Incidentally, in case you haven't gotten into it, Cornelia Van Tienhoven is the daughter of Dr. Lucas Van Tienhoven, the son of the Secretary of New Netherland, Cornelis Van Tienhoven. Cornelis was such a scoundrel and so hated by the people that there appears to be very little written on his descendants at least not as far as I have been able to find.
- "I have noticed that some researchers refer to Mary Haldron as Mary Elizabeth or Elizabeth Mary, and perhaps they are making the same assumption as I.
- "Unfortunately I seem to have come to this conclusion regarding her ancestry more by a process of elimination than by proof of her parentage. I would prefer the other way around."

Thanks, Joan, for that information. It is more than we had before.

### OUR COLLEGE PRESIDENTS

Members of the Bunnell/Bonnell family have been particularly distinguished in the field of higher education. In the last issue I mentioned John Mitchell Bonnell CB003140, fifth president of Wesleyan Female College at Macon, FA, 1860-1871.

Charles Ernest Bunnell, CB340113, in 1922 became the first president of the Alaska Agricultural College and School of Mines, a position he held for 25 years, during which time the college became the University of Alaska. The story is told in "FARTHEST NORTH COLLEGE PRESIDENT," by William R. Cashen, a copy of which I am anxious to secure.

I have been told, but have not yet confirmed, that a Bunnell was president of Bucknell University at Lewisburg, PA.

And now I have just received a letter from one of our subscribers, Allen T. Bonnell, of Wallingford, PA, who says, "My own career has been in higher education. I have taught at the University of Illinois, St. Louis University, and the University of North Carolina, Chapel Hill. From 1948 until 1965 I was Vice President of Drexel University and from 1963-65 Vice President and Provost. In 1965 I accepted an invitation to become the founding president of Community College of Philadelphia, from which post I retired in September, 1983. The College was started from scratch and now has a beautiful center city campus and serves some 20,000 students."
