In this issue the family of Jonathan and Elizabeth (Bryant) Bonnell is grafted to the family tree. Many of you have been searching for the solution of your Bunnell or Bonnell ancestry for a long time. I hope and expect that with patience and diligence we will be able to bring you the answers. ANOTHER BUNNELL GENEALOGY

Joan Murray, Palatine, IL, one of the early subscribers to the Newsletter, has sent me a good deal of information, both from her own researches and from miscellaneous Bunnell references which have come to her attention. Now she tells me that her family research has culminated in a book to be published on 15 October 1990. It is entitled "BUNNELL AND ALLIED FAMILIES", including the lines of Atwood, Baldwin, Barkeloo (Van Borkeloo), Bordingh, Cortelyou, Decker, England, Haldron, Jackson, Jayne, Kermer, Kortright (Van Kortryk), Leonard, Mallory, Miles, Nicholls, Norton (George), Norton (John), Pels, Plumb, Preston (William), Roosa, Van Etten, Van Tienhoven, Vigne, Wilmont, Woodhull.

The pre-publication notice states: "The emigrant ancestor, William Bunnell, sailed on the Winthrop Fleet of 1630 settling first at Watertown, Massachusetts and then at New Haven, Connecticut. Although he eventually returned to England, he left behind descendants who made substantial contributions to the New England and New Netherland Colonies." The family history follows the Bunnell line down through nine generations and includes detailed information on the Bunnells and all the female lines listed above.

"The book contains 382 pages with an index of over 800 surnames. Included is a complete bibliography listing the 329 sources used to compile the history. Pictures, charts, and copies of original documents are included. Both editions are printed on acid-free paper."

In July Clement M. Bonnell received an invitation to a 1990 Bonnell Family Reunion in Orange co, NY. He said he did not know how they got his address. He was unable to attend because of another commitment and sent the invitation on to me.

The invitation was sent by Marion Swinden, Walden, NY. I called her immediately and learned that the reunion was that of the descendants of Daniel Reynolds Bonnell, 1823-1894, one of the many unattached branches in my files. She invited Pat and me to attend.

Accordingly, on 12 August we met with them at Stony Ford Park in Orange co. Marion Swinden is one of the nine children of Ross Henry and Lula (Turner) Bonnell. Ross Henry Bonnell, CB010045, was the son of William Henry and Emma L. (Dixon) Bonnell. William Henry Bonnell, CB005006, was the son of Daniel Reynolds Bonnell, CB004840, by his first wife Sophia Hardenburgh.

Many years ago I obtained considerable information about the descendants of Daniel Reynolds Bonnell through his second wife, Sarah Ann Hotchkin, by correspondence with a descendant, Mrs. E. B. Brown. Her son Geoffrey Brown is currently a subscriber to the Newsletter. (I was a little disappointed that neither Mrs. Brown nor Geoffrey was able to attend the reunion this time).

However, my information about the descendants of the first wife was limited to the data collected by Claude Bunnell in his Database. Mrs. Swinden had compiled a large notebook full of genealogical data on the descendants of Daniel R. and Sophia down to the present day. She generously allowed me to bring it home to copy. I made copies of 100 pages of notes and returned the book to her promptly.

Because some of the family members come from as far away as Oregon, this particular reunion is held every other year. Mrs. Swinden has promised to alert me about time and place of the next one in time to get an advance notice in the Newsletter.

It was a pleasure to meet with a new branch of the family, and I am grateful to Clem Bonnell and Marion Swinden for making it possible. Now if we could only solve the problem of the parentage of Daniel Reynolds Bonnell

THE ADIRONDACK CHAIR

I hope that all of you will continue to keep your eyes open for miscellaneous references to the activities of Bunnells and Bonnells and to pass them along to me. They can be extremely useful. An excellent example is an article from the Buffalo Magazine entitled "A Chair for All Summers," recently sent to me by Mrs. Ralph Bunnell, Kenmore, NY.

You may remember that in Vol. II, No. 2, of the Newsletter I printed a short piece about the invention of the Adirondack chair and about HENRY BUNNELL who patented it.

Now, the article Mrs. Bunnell sent gave me the clue I needed to identify him. In this article his name was given as HARRY BUNNELL, a Westport, NY carpenter, who patented the chair in 1904. So I checked Claude Bunnell's Database to see if there were any Bunnells in the 1900 census in Westport. Lo and behold, there were only two, HARRY E. BONNELL, carpenter, and his daughter Rita S. Bonnell.

Harry E. Bonnell, CB340916, was born in August 1867 in Dyberry twp, Wayne co, PA, the son of Elijah Day, CB330644, and Mary W. Bonnell. Harry appears in the 1870 and 1880 census in Dyberry twp, living with his parents, as well as in the 1900 census in Westport, Essex co, NY.

I never would have found him as long as I was looking for Henry instead of Harry. Now I wonder whether he used Bunnell for his surname, or Bonnell as his ancestors did. Does anyone know how I might get a copy of his patent application?

Mr. Bunnell was born in New Haven on June 29, 1942, a son of Kathleen Enscoe Bunnell of Hamden and the late George W. Bunnell. He was a Milford resident for the past 20 years.

He was a mechanical designer for Bolt Technologies in Norwalk for nine years and had previously worked at U.S. Electrical Motors for five years.

Mr. Bunnell was a past president of the Milford Jaycees and a past president of the Connecticut JCI Senate. He was awarded the Connecticut Jaycees Outstanding Young Man Award in 1977 and in 1982 received the organization's Statesman Award.

He was president of Milford Operation Mainstream Inc., a non-profit agency connected to the Special Olympics. He was a member of the Republican Town Committee and the Elks Lodge.

Mr. Bunnell was a parishioner of St. Mary's Church.

In addition to his wife and mother, he is survived by a son, Matthew G. Bunnell, and a daughter, Ellen M. Bunnell, both of Milford; two brothers, George W. Bunnell of Hamden and David F. Bunnell of Saskatchewan, Canada; and a sister, Ann Nancy Lynch of Branford.

NAMES ON THE LAND

This picture was taken many years ago about 4 or 5 miles from our home. The sign was located on U. S. Route 6, the Roosevelt Highway, between Meshoppen and Laceyville, PA, overlooking the Susquehanna River. The road was rebuilt in the early 1960's, a substantial cut was made on a new location, and the sign was never replaced. This picture was submitted by Mrs. Ralph Bunnell, Kenmore, NY. I have a similar shot on a colored slide taken by my father-in-law.

Locally this stretch of the road is known as Keeney Heights. Bunnell Hill is usually thought of as comprising a network of county and town roads just to the north of the Highway.



The name honors several sons of Benjamin, CB300045, and Catharine (Barry) Bunnell who established farms on the Hill in the 1820's.

BUNNELL SELECTED FOR MANSFIELD HALL

Former Tunkhannock High School sports coach George "Duke" Bunnell has been selected for induction into the Mansfield University Alumni Athletic Hall of Fame.

The former three-sport star at Mansfield will be honored at the homecoming activities on Saturday, Oct. 13, although a recent fall that resulted in a broken leg may keep the former Tiger coach from participating in the induction ceremonies.

A native of Meshoppen, Bunnell joined the THS faculty in 1934 following his graduation from MSTC. He coached until the spring of 1958 when he left to teach and coach at Wellsville, N. Y.

Bunnell was an active member of the Tiger sports programs, with the exception of the two and one-half years that he spent in the Marine Corps during World War II, for a total of 21 years.

His football record was a phenomenal 117-59-12 with his last nine seasons producing a sparkling record of 68-12-1. During the 1950s Bunnell's football teams went unbeaten five times.

In addition to football, Bunnell also was a successful baseball, basketball and volleyball coach. In baseball, his Tigers won 12 District 12 titles and six Back Mountain League crowns as well as the Suburban Baseball League title with an 8-0 record in his last season.

After a second place finish in the PIAA State Tournament in 1955, Bunnell guided the Tigers to their first state title in volleyball in 1957.

Bunnell also was the Tigers' basketball coach for six years and also took the reins of the track team in 1943 and led the local thinclads to a District 12 championship.

Bunnell and his wife, Diane, who was also a faculty member for many years at THS, reside in Corning where the coach is currently recuperating in the Corning Hospital.

If Bunnell and his wife are able to attend the induction ceremonies, they will ride in the homecoming parade, be introduced at half-time at the football game and be the guests of the president at a reception after the game.

In a related matter, the Bunnells announced that their son, George L., was recently promoted to the rank of staff sergeant in the United States Marines. The younger Bunnell is stationed in California.

(George Lewis "Duke" Bunnell, CB340332, was born 31 May 1908, the son of Lewis M., CB330368, and Belle (Winans) Bunnell. He married Diana Gallaher. Their son George Lewis Bunnell, Jr., CB351947, was born 8 October 1958. – wra)

Many of you have purchased Ruth Duncan's excellent book, WILLIAM BUNNELL AND HIS DESCENDANTS. From time to time Ruth sends me additions and corrections to the book. (Note the obituaries of John J. Bunnell and Mrs. Patricia Packer in this issue.) I will pass them along to you, along with additions and corrections from other sources, to help you keep your books up to date. Here are a few Ruth sent me last year:

Page 306: Rene Bunnell Tripp died 10 Dec. 1986.

Page 49: William Bunnell #62 married RUTH TULLER, 29 May 1796 in Simsbury by Dudley Pettibone, Justice of the Peace. (Note: The records of Dudley Pettibone were just given to the Simsbury Historical Society, up to this year his records were kept by a descendant of his and were not recorded anywhere.)

Page 36: Zethan, son of Noah #36, married Jerusha Hutchinson. The Litchfield County, Conn. Superior Court records of 1750-1809 state: "Jerusha Bunnell of Hartford married Zelhun Bunnell of Hartford in 1803. He abused her and then deserted her. She was granted a divorce in Nov. 1808."

Page 351: John Calvin Bonnell II died 14 March 1987 in Moorestown, N.J. (His obituary appeared in the Bunnell/Bonnell Newsletter, Vol. II, No. 3 – wra.)

Page 47: Robinson, son of Joel #57. Springfield, Mass. vital records states: CYRUS ROBINSON BUNNELL, son of Joel was born in 1814 in Berlin, Conn. and died in 1862. He married MARY MATTHEWS of Springfield, Mass. 24 Feb. 1853. She was born in 1821 in Cambridge, Mass. Cyrus was a resident of Windsor, Conn. at the time of his marriage to Mary. This was his 2nd marriage and her first. He resided in Granby, Conn. at one time and had children Cornelia and Henry. I do not know which wife these children were by.

More recently Ruth sent me the following note from the Granby, CT, Civil War Records: Cyrus R. Bunnell Mary Louise Bunnell (Wife) Cornelia J., b. ca. 1853 (dau.) Henry B., b. ca. 1856 (son) Civil War reports say Cyrus died Dec. 30, 1862, Co. B, 10th Conn. Regt.

Clement M. Bonnell III, of Milford, NJ, recently submitted a correction to page 317 of Ruth Duncan's book. The information was obtained from Mrs. Jeannette (Bonnell) Lance. Following is the article on Horace A. Bonnell CB002204, revised to incorporate Clem's new information:

783. HORACE AUGUSTUS⁹ BONNELL, son of Mahlon, was born 10 Sept. 1869 in Baptistown, New Jersey and died 18 May 1954 in Glen Gardner.

He married ANNA MAY SHANNON, daughter of John and Sarah (Beavers) Shannon. She was born 21 June 1870 in Glen Gardner, New Jersey, and died 19 May 1942 in Glen Gardner.

When their daughter Nettie died three days after the birth of her daughter, Horace and Anna adopted their granddaughter Jeannette. Her name was changed from Brundage to Bonnell, and she was raised like a sister to her aunt Agnes.

Horace's obituary in the New York Times states: "Horace A. Bonnell of High Bridge, died 18 May at Glen Gardner, age 84 years. At the turn of the century he was secretary and treasurer of the New York Giants baseball club. He was the main distributor for the State of New Jersey for the Dodge Corporation; former secretary of the Auto Trade Association of New Jersey; and president of the Bonnell Motor Car Co. of Newark."

ANOTHER PROBLEM SOLVED, I think!

For a long time the parentage of the Jonathan Bonnell who married Elizabeth Bryant has eluded me. Recently, as I was going over the notes of my unattached families, the pieces seemed to fall into place.

Although it has been copied in other publications, the only source I have found for this family is the "Carteret and Bryant Genealogy," by Catherine Romana Baetjer, 1887, in which it is stated that "Elizabeth, daughter of Hannah and Cornelius Bryant, was born at Springfield, New Jersey, in the year of 1768, married Jonathan Bonnell of Chatham, New Jersey, and their children were:

Johnathan,

Charlotte.

"Elizabeth, widow of Johnathan Bonnell, married John Ballentine, of Edinburg, Scotland. By this marriage there was one daughter, Eliza H., born in New York, July 14th 1799."

Elizabeth, widow of John Ballentine, married Samuel Williams, of Hackensack, New Jersey; no children. Elizabeth, widow of Samuel Williams, died at Elizabeth Town, New Jersey, June 26th, 1845; interment, Mount Pleasant Cemetery."

The Bonnell families in Chatham, NJ, are fairly well accounted for. Nathaniel Bonnell, CB300178, and his wife Elizabeth Allen had a son Jonathan born in March 1765 and baptized 23 June 1765 in the Presbyterian Church of New Providence, NJ. John Littell, in "Genealogies of the First Settlers of Passaic Valley (And Vicinity),"

1852, says this Jonathan died young, an expression which usually means died in infancy or childhood, and most accounts have left it at that.

However, the will of Nathaniel Bonnell, dated 10 October 1808, when Jonathan would have been 43 years old, makes it clear that Nathaniel did not know whether Jonathan was still living or whether he had children. The will states, "If Jonathan should not be living and had no lawful heirs the £20 given to my daughter Elizabeth should be paid out of the estate which would have fallen to him." Thus it is certain that Jonathan had not died in childhood and that his father had completely lost touch with him.

I am convinced that this is the Jonathan Bonnell of Chatham who married Elizabeth Bryant. He was already dead when his father wrote his will, since his widow Elizabeth had remarried and had a daughter by her second husband, born 14 July 1799 in New York.

We do not know where Jonathan died, but I would guess that it was in New York. Elizabeth's daughter, Eliza Ballentine, was born there, and Jonathan and Elizabeth's daughter Charlotte married George Pattent of New York. Their son Jonathan, Jr., married Sabina Ferris, of Greenwich, CT, where he apparently lived the rest of his life.

Claude Bunnell in his Database indicates that this Jonathan, CB310363, son of Nathaniel, CB300178, married Mary Burnet. Claude lists no children for this marriage. Littell's Passaic Valley gives Mary Burnet as the wife of another Jonathan Bonnell, CB310318, son of John, CB300181, and Sarah (Carter) Bonnell. Littell goes on to say that sisters, Mary and Rosa Burnet, married brothers, Jonathan and James Bonnell. I believe that Littell is correct in this matter. Mary Burnet was the mother of Matilda, Ichabod, Joel, Alva and John Bonnell, all mentioned in the will of their grandfather John Bonnell, CB300181.

Combining this information with inscriptions from Greenwich, CT, grave stones which I had not previously connected, lets me put together the following for families of Jonathan and Jonathan, Jr.:

1-2-1-2-4-6 (D64vi) CB310363

JONATHAN BONNELL, son of Nathaniel, was born March 1765 and baptized 23 June 1765 in the Presbyterian Church of New Providence, Essex (now Union) co, NJ. He was "of Chatham," Morris co, NJ, when he married ELIZABETH BRYANT, daughter of Cornelius and Hannah Bryant. She was born at Springfield, Essex (now Union) co, NJ, in 1768. Jonathan died before 1799, and Elizabeth married (second) John Ballentine, and (third) Samuel Williams. She died 26 June 1845 at Elizabethtown, Essex (now Union) co, NJ, was buried in Mount Pleasant Cemetery.

Children:

- 1. Jonathan, b. 28 Feb. 1791.
- 2. Charlotte, m. George Pattent; no children.

Jonathan appears in the 1830 census: 201001-131011 and the 1840 census: 12200001-0022001-01, both in Greenwich, CT. Jonathan died 17 September 1843 at Greenwich, CT. His real estate was sold to his son George, and on 5 November 1844 Sabina was appointed guardian of her minor children. Jonathan's estate was probated in 1848 in Greenwich. Sabina survived him until 26 May 1876. She appears in the census in Greenwich in 1850, 1860 and 1870. Her estate was probated in 1876. Jonathan and Sabina were buried in the Bonnell Cemetery at Steep Hollow on the cross road to North Cos Cob, Greenwich, CT.
