Halbert's of Bath, OH, is at it again. They are publishing another list of Bunnell names and addresses. At least two of my subscribers, Bill Bunnell of Concord, NH, and Ralph Bunnell of Kenmore, NY, have received ads for it, and Bill sent me a copy of the ad. This time the ad purports to come from "James D. Bunnell, Director," as if it were actually being prepared by and for a Bunnell family.

This time the list is more international in scope and has been titled "THE WORLD BOOK OF BUNNELLS," claiming 2,034 households bearing the Bunnell name in the United States, Canada, Australia, New Zealand, England, Scotland, Wales, Northern Ireland, Ireland, Germany, Austria and Switzerland. The ad states that the book. now includes the names of individual Bunnells who immigrated to the New World between the 16th and early 20th centuries.

Much of the text of the ad is taken verbatim from the ad which Halbert's sent out for "THE AMAZING BUNNELL FAMILY ALBUM AND NEW WORLD REGISTRY," in 1988, including this statement: "Please note, however, that this First Edition is expected to be the only printing of the Bunnell book, ever." If you have need for a list of Bunnell names and addresses, the book might be worth the \$36.40 to you, although I am sure your need can be satisfied core cheaply. If it is genealogy you are interested in, don't waste your money.

In the last Newsletter I printed a note about Sharon Kay Bunnell of Trenton, ME, who was listed in the 1971 issue of OUTSTANDING AMERICAN HIGH SCHOOL STUDENTS. Clem Bonnell of Milford, NJ, took the initiative and made contact by phone with Sharon, her sister Kathy, and then with their father Ray Bunnell. What he learned established Sharon Kay's descent as: William, Nathaniel, Nathaniel, James, Stephen, David, Barton, Stephen J., George Washington Osbome, clarence, and Ray Bunnell CB360764. Ray married Bess \_\_\_\_\_ and had nine children:

Kathy, m. Bill Stienke; Carol, m. Larry Vlasin; Ray, Jr.; Larry, d. at age 5; Sharon Kay, m. Vie Larson; Jean May, m. Curt Stienke; David A.; Laurie, m. James Keeler; and Donald. Thanks, Clem, for your help!

## ISAAC

Charlotte Blair Stewart suggested that, while current obituaries are interesting, articles which provide information on early branches of the family can be more helpful. Since one purpose of the Newsletter is to serve as a record repository for the future, I will continue to print obituaries, weddings and similar current news items as I receive them. Please keep sending them in.

At the same time I recognize the force of her suggestion. Extracts of early records, such as census, vital and military records will be included, and I will try to focus on unplaced members of the family, in each Newsletter. For this issue I have chosen the unplaced ISAACs who were born before 1800.

The chart on the following page traces the male descendants of William Bunnell, the immigrant ancestor, for the first five generations, showing only those lines in which the name ISAAC was used. For example, William's son Benjamin had four sons who reached adulthood, Benjamin, Hezekiah, Nathaniel and Israel. As'far as I know, only the eldest, Benjamin, had any descendants named ISAAC. The other three sons, Hezekiah, Nathaniel and Israel, all had numerous descendants, but I have found no ISAACS among them; the chart omits their descendants.

My intent is to highlight the lines in which'the name ISAAC was traditional. In the last column some of the names are followed by arrows-—>- This indicates that the man had a son or grandsons named ISAAC in the generations beyond reach of the chart.

Names followed by double asterisks identify those persons who are likely to have had children unknown to our records—thus, possible fathers or grandfathers of the unplaced ISAACs which I will discuss. (See Newsletter Vol. III Nos. 1 and 2, for more about these "empty branches.")


NOW for the ISAACS:

CB002970 Rev. ISAAC BONNELL, born about 1730, was a Baptist minister who died 25 July 1794 in his 64th year. He was buried in the Tuckahoe Baptist Burying Ground in Cape May co, NJ.

[I have found no further information about this man. Based on his date of birth and his name, I suggest that he might have been the son of Jacob, b. 1702, John, b. 1704, or William, b. 1706. The age would have been right, and it would be logical to have been named after his grandfather and uncle.]

CB300184 ISAAC BONNELL, Loyalist, was born 29 August 1738 in New Jersey. A friend of New Jersey Governor William Franklin, he was appointed Sheriff of Middlesex co. He was a Loyalist during the Revolution, after which he removed to Digby, Nova Scotia. He died there 7 November 1806.

[Considerable information has been found regarding ISAAC's life and career. However, we have not discovered his parents. Could he have been son of one of the three brothers noted above, and thus first cousin of Rev. Isaac Bonnell?]

CB005633 ISAAC BONNELL was born about 1755, probably in New Jersey. He married there Catherine (Severns?). Sometime before 1800 they moved to Virginia. The last three children, at least, were born there, and some of the older children married in London co, VA. In 1808 he bought land in Crawford co, PA, and he appears there in the 1810 census. He moved on to Guernsey co, OH, where he bought land in 1814. He appears on the 1820 and 1830 census in Guernsey co, and he died there in 1834. He and Catherine had at least 11 children, and many of these descendants are searching for his ancestry.

[Barring the false alarm noted below, no clues to his parentage have turned up yet.]

CB002973 ISAAC BONNELL, son of Samuel and Mary Bonnell was baptized 19 August 1755 in Elizabeth, Union co, NJ, as recorded in the 1988 issue of the International Genealogical Index.

[At first glance this would appear to give us the parents of ISAAC CB005633 who was born about 1755. However, in the same IGI listing we find Samuel, son of Isaac Bonnet, and Mary, daughter of Isaac Bonnet, both baptized in St. Johns Episcopal Church, Elizabeth, Union co, MJ, on 19 August 1755. This looks to me like too much of a coincidence. The baptism of Isaac Bonnell was processed in IGI in 1972, while the baptisms of Mary and Samuel were processed in 1976. Mary and Samuel were clearly the two youngest children of ISAAC BONNELL CB300197, b. 1702. Mary was born in 1748 and Samuel in 1750. I suggest that in the record processed in 1972 the submitter got parent and children switched. I believe we must continue to search further for the parents of ISAAC CB005633.]

CB000663 ISAAC N. BUNNELL, born in 177x, married Thankful \_\_\_\_\_, who was born in 1778 in Massachusetts. They appear in the 1840 census in Union, Broome co, NY. He died there in 1848. The widow Thankful Bunnell appears in the 1860 census in Eulalia twp. Potter co, PA, living with her son Jeremiah, who was born in Massachusetts in 1823.

[This information comes from Claude Bunnell's Database. At first, I confused this person with Isaac Bunnell, son of Jonathan and Mehitable (Morse) Bunnell. The dates of birth and death are very close. They each apparently came from Massachusetts to New York state, and they each had a surviving widow who was born in Massachusetts. However, the similarities were not enough to overcome the evidence of different wives, and different places of residence.]

CB011458 ISAAC BUNNELL witnessed a deed in Mason co, KY, in 1798.

[I see no other reference to this man. Is he related to one or more of the Bunnell/Bonnells of Kentucky which I discussed in Newsletter, Vol. VII, No. 2?]

CB010012 ISAAC BONNEL, probably born before 1800, appears on the tax list in Orange twp, Essex co, NJ, in 1822.

[Perhaps a grandson of ISAAC, born 1702.]

ISAAC cont'd)

CB001343 ISAAC BUHL appears in the 1830 census in Ossian, Allegany co, NY, as: one male between 5 and 10, one male between 10 and 15, and one male between 30 and 40; 3 females under 5 and one female of 30 to 40.

[I believe this to be a case in which a person, because of a move during the year, is counted twice in the 1830 census. This must be the same person as the ISAAC BUNNELL CB320212 who appears in the 1830 census in Candor, Tioga co, NY, as: one male between 5 and 10, one male between 10 and 15, and one male between 30 and 40; 2 females under 5, 2 females between 5 and 10, one female between 30 and 40, and one female between 50 and 60.]

CB010831 ISAAC BUNNELL, who died 24 December 1814 at the New York General Hospital from wounds received in the War of 1812.

[Ruth Duncan identifies him as the son of ISAAC, b. 11 May 1759, and grandson of ISAAC, 1734-1808. This seems unlikely. The Isaac who was born in 1759 died before 1790, when his widow, the former Hannah Tyler, appears as head of household in the census in Derby, CT. One male under 16 years is listed, her son Clark, b. 1781.

Claude Bunnell, on the other hand, identifies him as son of Israel 1746/7-1813, grandson of Ebenezer, 1713-1786, and great-grandson of Nathaniel 1686-1732. Claude does not indicate his evidence for this identification, and I have not found any. However, the 1790 census in which Israel 1746/7-1813 appears as head of household shows another male over 16 who is unaccounted for in my list of Israel's children. It is conceivable that this could be a son who grew up to become father of this ISAAC.]

CB010835 ISAAC BUNNELL, born 179x, appears in the 1820 census in Dennysville, Cumberland co, ME: 1 male between 18 and 26; 1 female under 10 and 1 female 16 to 18 years.

[Could he be a grandson of one of the sons of Gershom 1707-1758? I don't know of any Bunnell family in Maine in which he could fit.]

CB005767 ISAAC BUNNELL was born in 1798 in North Carolina. He appears in the 1830 census in Currituck co, NC, and in the 1850 and 1860 census in District 4, Dyer co, TN.

[Probably son of Moses Bunnell CB004101 who appears in the 1800, 1810 and 1830 census in Currituck co, or of Embly Bunnell CB004144 who appears in the 1790 and 1800 census 'in Currituck co, and whose will was proved there on 31 January 1803. I haven't seen the will itself, which might answer the question.]

I hope this discussion will encourage someone to dig out more information which will help us identify these ISAACs. Future issues will take a look at similarly unplaced Benjamins, Nathaniels and other names. Let me know what you think.

## WILLIAM BUNNELL, THE IMMIGRANT

The Great Migration Study Project, a project of the New England Historic Genealogical Society, is engaged in identifying and studying all those persons and families who arrived in New England between 1620 and 1643. To inform interested persons of their progress, the "Great Migration Newsletter" is published quarterly. I have been a subscriber to the Newsletter since the first issue in early 1990.

In Vol. 3, No. 4, October-December 1992, there is an article of particular interest to us. I requested and have obtained permission from the editor, Robert Charles Anderson, to reprint the relevant paragraphs. Although the article does not present any information about William Bunnell which I have not already published, the rigorous approach which the Study project uses in considering the available data provides a worthwhile example for us in our own research.

### "SAME NAME, SAME PERSON?

"A common problem encountered by all genealogists, regardless of the time or place being researched, is deciding whether two records which include the same name apply to one person or to two. In the early stages of the Great Migration Study Project this problem arises very frequently in a specific form: a name appears in a record of, say, 1630, and then does not appear again for a decade or so, after which it is seen regularly. Aside from the general genealogical problem presented, this also determines who will make it into the early sketches of the Project, which apply only to people who had arrived by the end of 1633.

"Several fairly simple examples of this sort of problem are seen in a single early record, the 28 September 1630 inquest into the death of Austen Bratcher 'dying lately at Mr. Cradock's plantation\* (Records of ... Massachusetts Bay... 1:77-78). A jury of fifteen men (equivalent to a coroner's jury) was convened to 'inquire concerning the death of Austen Bratcher.' Fourteen of these men are attested in other records in 1630, and regularly in years thereafter. The fifteenth juror, however, William Bunell, presents a different pattern. There is no other record for him in 1630, whereas the other fourteen appear in the list of those asking to be made free on 19 October 1630, or the list of those admitted to freemanship on 18 May 1631, or both.

"The next record for a man with the name of William Bunell is not until 7 October 1640, when the court 'desires Watertown to grant Willi: Bunnell a lot, & if be do prove chargable, the country to bear it.' There are no records in Watertown for this "man, although a few further entries are found in the colony records. There is nothing in this sequence which demands that there were two different William Bunells, but there is equally nothing to demand that the man of the 1630 record was the same as the later man of the same name who begins to appear in 1640. (There was also a William Burnell of Boston, who is yet another man.)

"A general principle guiding all decisions about inclusion in or exclusion from this first phase of the Great Migration Study Project is that we must have explicit grounds for stating that someone was here by the end of 1633. In this case we certainly have a record for a William Bunell in 1630, and so there will be an entry under this name. But we

can not be certain that he is the same as the William Bunnell of 1640 or later. Certainty is not necessary but here we do not even have circumstantial evidence which would connect the two records. The .sketch for William Bunell will give the 1630 record, and then in a Comment' section point out the later records, and the reason for not connecting them. We will never in such cases simply ignore such possible identifications. This has the merit of not including information that does not belong at this point; if newly-discovered evidence or better analysis proves that the 1630 and 1640 records apply to the same man, so much the better, and an appropriate emendation may be made at that time."
