COMMENT

Renewal notices for 1996 are included with this issue. 1996 will mark the tenth year of publication. I am finding it increasingly difficult to apply the time it takes to prepare the Newsletter. At the same time, many other interests have had to be laid aside. Therefore, I have decided that 1996 will be the final year for me as editor and publisher of the Newsletter. During the coming year I hope that someone else will come forward and offer to take over its publication in 1997 and beyond. How about it? Do I hear a volunteer? Naturally, I don't expect to lose interest in the Bunnell/Bonnell family. Perhaps I'll even manage to get caught up on my correspondence.

* * *

In July Pat and I attended the Sesquicentennial Conference of the New England Historic Genealogical Society in Boston. This is the oldest genealogical society in the country, if not the world. It was founded in 1845 and began publication of the quarterly Register in 1847. I joined in 1955. The Conference provided a broad selection of seminars on many subjects, including a strong emphasis on the uses of computers in genealogy. The keynote speaker was David McCullough, author of THE GREAT BRIDGE, TRUMAN, and other major historical works. We also had the opportunity to spend most of one afternoon doing research in the Society's library, one of the most comprehensive in the country. I discovered a number of additional ancestors in my French Canadian line.

At the Conference the first volume of THE GREAT MIGRATION BEGINS, by Robert Charles Anderson, was issued. This includes brief sketches about all persons who came to New England before 1634. William Bunnell is included, based on his appearance on the jury list in 1630. The author mentions the references to William Bunnell in the court records of Massachusetts Bay in the 1640's, but cannot be certain that they refer to the same person. Mr. Anderson wondered about the identity of the grandfather of William's children mentioned in the record of October 1645. I met Mr. Anderson and told him the grandfather was Benjamin Wllmot. After I returned home T sent him a copy of my intensive study of William Bunnell and his origins.

COMMENT (Cont'd):

Hugh Bunnell, of Rush, PA, and Port Charlotte, FL, visited us here at Camelot one day this summer. He was particularly interested in the journal kept in 1876 by Melvill Lamont Bunnell (See Newsletter, Vol. IX, NO. 3, in which I mistakenly gave the date as 1872). Hugh's father and Melville were first cousins, and the journal mentions many of their near relatives.

* * *

Florence Buck, of Starucca, PA, and Skaneateles, NY, sent me two old pictures which she found among her family heirlooms. She is a great granddaughter of Martin Bunnell CB320015, and she wondered if the home in the pictures was Martin's homestead in Herrick twp, Susquehanna co, PA. One picture showed a family of mother, father and three sons standing in front of the house. The second picture, obviously taken four or five years later, showed the same family plus an elderly gentleman seated in a chair.

Martin Bunnell was born in 1800 in Connecticut, son of Miles and Amelia (Doud) Bunnell. (See Newsletter Vol. IV, Nos. 2 and 3, for discussion of his ancestry.) He moved with his parents to Rush twp, in what is now Susquehanna co, PA. At age 15 he went to Delaware co, NY, to live with a relative, David Kelly. He was married there in 1827 to Irena Anna Keator and moved to the farm in Herrick twp, PA, where they spent the rest of their lives. The farm passed in time to his son Lewis Martin and then to his grandson Ralph Decatur Bunnell.

I was unable to match the family in the pictures with that of Martin Bunnell or of his sons. However, the 1869 Atlas of Susquehanna County clearly identifies the home of Martin Bunnell in Herrick twp. My wife and I set out one day to see if it is still standing and to try to match it against the picture. We found an old farmhouse in the right place. There were many structural similarities with the house in the picture, but also many differences.

I introduced myself to the lady of the house, who assured me that this was the Bunnell homestead built by Martin Bunnell and owned by his descendants for many years. She, Nancy Ross, and her husband Bruce bought the place some years ago, remodeled it and furnished it throughout with period antiques. Mrs. Ross graciously invited us in and gave us a tour of her home.

After examining our old picture carefully she concluded that it was not the same house. Then she brought out several pictures of the house taken in the 1920's when it was owned by Martin Bunnell's grandson, Ralph Decatur Bunnell CB340220, a New York City stockbroker. He had remodeled the house extensively in his day, adding among other things the two fireplaces with their stone chimneys. Mrs. Rose arranged to get copies of her pictures for me. She also put me in touch with Mrs. Anne Fleming, Pasadena, CA, daughter of Ralph Decatur Bunnell.

Here are two views of the house as it appeared in the 1920's.





Ellen Dorn, Manhattan Beach, CA, reports a bit of luck in her family research. She wrote to the Society of Friends in Ottawa, Canada. Her letter was forwarded to the archivist at Pickering College in Newmarket, Ontario. She received in return a copy of a page from the Index-Yonge St. Monthly Meeting, in Newmarket. The Index was furnished by CYM Archives, Pickering College, Newmarket, ON, CAN L3Y 4X2. The archivist is Jane Zavitz-Bond.

Aaron Bonnell, son of Henry CB002141 and Margaret (Burwell) Bonnell, born 3 June 1807, was Mrs. Dom's great grandfather. It is the first primary record she has found which gives Aaron's parentage explicitly. Other descendants of Henry and Margaret may also find the Index useful.

The Yonge St. Monthly Meeting (Newmarket) was established in 1806. Vital statistics prior to 1806 were under Pelham Monthly Meeting as the nearest "official" meeting to Yonge St. (Friends settled in Newmarket area by 1801.) Mrs. Dorn notes that the marriage of Henry Bonnell to Margaret Burwell on 4 February 1801 was recorded at the Pelham Monthly Meeting. Here is the list of Bonnells as it- appears in the Index:

Final victor took 50 years

Purple Heart to be given Saturday

ELMDALE - The battlefields of Charles Bunnell's life

Later, it was military hospitals, where he fought to piece his





He knew he was alive. That was enough.

The night before, his B-24, painted black to avoid detection on its secretive nighttime runs, wasn't so lucky. It encountered heavy anti-aircraft fire over Cologne, Germany. Drastic evasive measures to avoid a German radar fighter further weakened Bunnell's plane.

Dubbed Lady Grace, the B-24

limped back to England.

"The next day we were or-dered up in the same damaged plane," Bunnell says. The crew went, no questions asked.

"We were young boys fighting a war. We wanted to win.'

Short flight

It soon became apparent that Bunnell and his mates wouldn't win much in Lady Grace. After takeoff, the plane's controls jammed. An engine burst into flames.

"We threw everything out of the plane that was loose, trying to gain altitude so we could bail out, but it didn't work," Bunnell

"We knew we were doomed. It was just a matter of when it would crash. We had no control. All we could do was pray."

That's all Bunnell will say about those terrifying 25 min-

"When you're staring death in the face, it's hard," he says. "There are things I can't talk about."

Amazingly, nine of 10 crew members survived the crash. Three walked away.

"If you don't believe in the Lord, today's the day to start," he remembers telling those who ran to help him after the crash. Then he asked them to find his good luck medallion and put it into his uninjured right hand where he could hold it tight.

Recuperation

Bunnell needed the silver dollar's luck in the days to come, when he had to persuade doctors not to amputate his arm. Victorious, he ended up in a body cast with his left arm held aloft in its own braced cast.

"I spent from March to November in the hospital. When I got discharged, it (a Purple Heart medal) was the last thing I was thinking about. I just wanted to get home," he says. He wanted to get back to the farm where he was born, back to the tractors, the fields and the farming he loved.

During the years, people who heard his story asked about the Purple Heart. Bunnell, never one to draw attention to himself, shrugged it off until he learned in 1989 that Reuben Hill, a waist gunner on his crew, re-ceived his Purple Heart while in the hospital in 1945.

"That's when I started pursuing it. You can't believe the doors that had to be opened and the doors that were shut in my face," Bunnell says.

"I wanted them to explain to me why one would get it and one wouldn't."

Maybe it was the covert na-ture of his assignment that tangled his records. Maybe it was because he was sent to a different hospital than the rest of his crew.

But the government appeared to have no record of a Sgt. Charles Bunnell involved in a

Loran Rutledge, Montgomery County service officer, eagerly jumped into the fray.

"It was quite an ordeal," Rutledge says. "I've been in this office 29 years and have had 10 cases that have really been difficult. Charlie's is one of them."

Rutledge enlisted the help of Steve Bryant in Sen. Richard Lugar's office. Still, doors slammed in their faces.

"Charlie said, 'Just forget it,' and I said, 'No, we're going to the highest of review boards," Rutledge says. "I knew he had a good case and I wasn't about to give up."

Proof positive

In the end, simple paperwork and a letter from Bunnell's crew mate Reuben Hill documenting the tail gunner's presence in the crash of Lady Grace represented the former sergeant before a review board in San Antonio.

It was enough. A letter admitting to a great miscarriage of justice and error - "one hell of an error," Rutledge says - informed Bunnell in July he would receive the Purple Heart.

"Once they acknowledged they made a mistake. Charlie got the medal within a week. It was the highest priority I've ever seen on a medal," Rutledge says.

He says he is disappointed that Bunnell could have shaved thousands of dollars off Purdue University tuition fees for his sons, Timothy and Michael, if he had received the Purple Heart back in 1945.

But in his style, Bunnell shrugs it off. He says he is fortunate just to be alive, to have

sons, his wife Mary Margaret, family and friends to share the joy of the official Purple Heart presentation. The ceremony will be 7 p.m. Saturday at Crawfordsville's VJ Plus 50 celebra-

His feelings today are much the same as that fateful day in 1945 that could have ended his

"I feel lucky," he says. "I owe all this to the good Lord."

THE CHILDREN OF DAVID BUNNELL CB310276

In the last Newsletter I discussed the family of Nathaniel Bunnell CB310277, and provided some evidence to suggest that Eliza Ann and John, usually included in lists of his children, were probably children of his brother David instead. I received a letter from Mrs. Frances Hanaway, whose husband is a descendant of Eliza Ann (Bunnell) Hanaway. Mrs. Hanaway makes the point that Eliza Ann has always been considered the daughter of Nathaniel, and that more evidence than I have given is needed before the record is changed.

I certainly agree that more evidence is needed to clarify the matter. There is no doubt that David had a daughter Eliza, probably posthumously, and that Nathaniel became her guardian. Did Nathaniel also have a daughter Eliza, born about the same time? That is not clear. David died intestate in Warren co, OH. His estate was probated there in 1816. Nathaniel died in White co, IN. His will mentions only his third wife and the three of his children born to her. His estate was probated in White co in 1850. Perhaps if someone could examine the actual probate documents in each case, more evidence might be obtained.

At the end of the article on Nathaniel's family, I said I would comment further in this Newsletter on David's children. In the past my list of children numbered 11: Ephraim, Barton, Brazilla, Sarah who married Ezekiel Laville (or Loud or Lond or Somel), Jonas, Elizabeth who married William Highfield, Veazey Price, Nancy who married her cousin Thomas Bunnell, Alfred, John, and Abram.

On page 33 of the July Newsletter I printed an extract from a document dated 27 October 1828 in Chancery Record #3, Warren co, OH, which says:

"the said David Bunnell died intestate having a widow and the following children and heirs, to wit, Ephraim Bunnell, Morton [actually Barton] Bunnell, Barzella Bunnell, Abraham Bunnell, Alfred Bunnell, Vesey Bunnell and James [Jonas?] Bunnell and the said Nancy, John T. and Eliza, the wards of your petitioner,"

This record raises serious questions about some of the reputed children of David. "Morton" Bunnell is clearly Barton, David's second son. Barton is well attested in later records. He was apparently named after his maternal grandmother, and the Barton name appears in the family more than once.

About "James" I am not so sure. Although all the other lists of David's children I have seen include Jonas and not James, none of the lists were apparently made during the life time of any of the family. Neither Jonas or James appears in any record I have found except on the lists of David's children and on the above Chancery Record. This child said to have been born 10 September 1803 was still living when his father died in 1816, and apparently even in 1828, when the Chancery Record was made. Because the record made a mistake in Barton's name, can we assume that it also mistook James for Jonas? Or do the lists of children, which may all have a common source, confuse James with David's brother Jonas? It is interesting to note that the 1830 census in Montgomery co, IN, lists a James Bunnel CB010892, 00002-0001, whose

parentage has not been identified. Most of the other children of David wound up in Montgomery co, IN, and I suspect that this is the "Jones" of the lists.

Next to consider is daughter Sarah, said to have been born in October 1801 (source?). She is supposed to have been the Sally Bunnel who was married 12 November 1820 in Warren co, OH. Her husband is variously given as Ezekiel Loud (IGI Ohio, 1988), Ezekiel Lond or Ezekiel Somel (occurring both ways in "Marriages of Yesteryear" (Warren co, OH) D.A.R., and Ezekiel Laville (CB Database). She was not listed as a surviving heir at the time of David's death. If he had a daughter Sarah, she probably died young, and we should look elsewhere for the parents of Ezekiel's wife Sally. I suppose it is possible that she was living in 1816 but was omitted from the list of children in 1827 because she had died without issue after she married Ezekiel.

Then we come to daughter Elizabeth. In Vol. IX, No. 2, I used a page and a half to separate the two William Highfields who married Elizabeth Bunnells. I stated there that one of the Elizabeths was the daughter of David and Elizabeth (Price) Bunnell. Now I have to question that. She does not appear in the list of David's survivors, although it is clear that William Highfield's wife Elizabeth Bunnell did not die until 1840. She might have been omitted in a will, but it is most unlikely that she would have been overlooked in an estate distribution of this kind. I have no suggestions as to her father if it was not David.

It would be most helpful if someone could get me photocopies of the actual documents in the probate settlement of David's estate. Claude Bunnell, in his Database, lists the reference as "PBN-OH165-prl pl37-bxl3 #5" Probate was in 1816 in Warren co, OH, and the widow Elizabeth was executor.

It is unfortunate that there are so few contemporary records to throw light on this matter. I would be happy to hear from anyone who wishes to comment or contribute to the discussion.
